

OCYS PLAYER/PARENT COMMITMENT

ALL SELECTED US CLUB PLAYERS ARE REQUIRED TO PERFORM AT THE FYSA TRYOUTS HELD TUESDAY AND WEDNESDAY AFTER MEMORIAL DAY.

Application is hereby made for registration of the player named below as a member of the Orlando City Youth Soccer (OCYS) for the 2018/2019 soccer season. The Parent/Guardian (I/we) understand that this commitment is for this **entire period**. I/We understand that the selection and team placement of players shall be at the sole and absolute discretion of the OCYS coaching staff. The continued participation of a player is contingent upon the player and family abiding by the rules, agreements, of OCYS and/or all other sanctioning bodies that issue a player pass.

All players are expected to meet a high standard of commitment to training and play. Players are expected to attend all practices, participate in all league games and tournaments, abide by the Player/Parent Code of Conduct and fulfill all requirements within the OCYS Financial Policies & Procedures.

We understand that each player and parent/guardian(s) registering to OCYS assumes a financial payment obligation. I understand and accept my commitment to the OCYS club. I hereby release any officers, coaches, sponsors, or owners/lien holders of properties used by the OCYS club from any and all claims and causes of action of any kind whatsoever which the undersigned has or might have, known or unknown, now existing or might arise in the future, directly or indirectly attributable to any injury or damage that might result from my child's participation in soccer activities:

Each player and their family are required to volunteer for OCYS a total of five (5) hours total during the seasonal year in support of OCYS. Volunteer hours can be substituted for Bright Future hours. ECNL PARENTS/PLAYERS ARE REQUIRED TO FILL TO VOLUNTEER SLOTS DURING THE DECEMBER ECNL SHOWCASE. ALL ECNL PLAYERS ARE REQUIRED TO VOLUNTEER 5 HOURS PER SEASONAL YEAR WITH THE LITTLE LIONS PROGRAM.
